INFORMATION ON THE PROCESSING OF PERSONAL DATA of donators in accordance with article 13 of Regulation (UE) 2016/679

WHY DO WE PROVIDE THIS INFORMATION In accordance with Regulation (UE) 2016/679 (henceforth “the Regulation”), this page describes the policy adopted for the processing of personal data of people making donations in favour of the institutional activity of Museo Egizio.

DATA CONTROLLER The data controller is the Fondazione Museo delle Antichità Egizie di Torino (henceforth named FME) with its registered office in Turin (To) Italy, Via Accademia delle Scienze n. 6, 10123 (email privacy@museoegizio.it, main switchboard +39 011.561.7776).

PURPOSE AND LEGAL BASIS OF DATA PROCESSING The personal data provided at the time of completing the form for donations is processed by FME for the bookkeeping of the project #museumsupporter and in the execution of its duties and purposes of scientific and informative dissemination regarding its activities. The following are the purposes for data processing (F) with the respective legal basis (B):

1. F: Administrative management of donations
B: The processing is necessary to fulfil a legal obligation to which the data controller is subject to.
2. F: Sending by email newsletter and/or communications on the initiatives of the museum by FME;
B: Consent
3. F: Processing of data for fundraising initiatives by FME for the management and the support of cultural heritage, or those in any case in its availability, received or acquired in any reason, and for museum initiatives, as well as related promotion and communication activities and formation.
B: Legitimate interest of the holder in pursuing a statutory purpose (Art. 2, c.2)

It is understood that the consent to the processing of data for purpose 2 is purely optional; therefore in the event of a refusal to give consent to the aforementioned purpose, the data will be processed for the sole purpose for which this consent is not required.

METHOD OF PROCESSING Data processing takes place through the use of tools and procedures that ensure a high level of security and confidentiality. It can be carried out with electronic tools, and in certain circumstances with the aid of hard copies.

DATA CONSERVATION PERIOD Data is held for a period of time that doesn't exceed the fulfilment of the purposes for which the data is collected and processed in accordance with the execution of the contractual purposes.

DATA RECIPIENTS FME employees and/or collaborators may have access to donors' personal data. These personnel, who are formally appointed by the company as "authorized to process" will process the user's data exclusively for the purposes indicated in this disclaimer and in compliance with the provisions of the Regulation. FME may give third parties, as "external data processors" pursuant to Article 28 of the regulation, the right to access personal data. These may be by the way of example suppliers of IT and logistics services functional to achieving the stated purposes, professionals and consultants.

RIGHTS OF THE INTERESTED PARTIES The interested parties have the right to obtain from FME, in the foreseen cases, access to their personal data or the modification or cancellation thereof, the limitation of their processing, or oppose their processing (artt. 15 and subs. of the Regulation). RIGHT TO COMPLAIN Any interested party believing that the processing of their personal data through this website is in violation of the Regulation have the right to file a complaint with the Controlling Authority, pursuant to art. 77 of the Regulation itself, or to take legal action (art. 79 of the Regulation)
